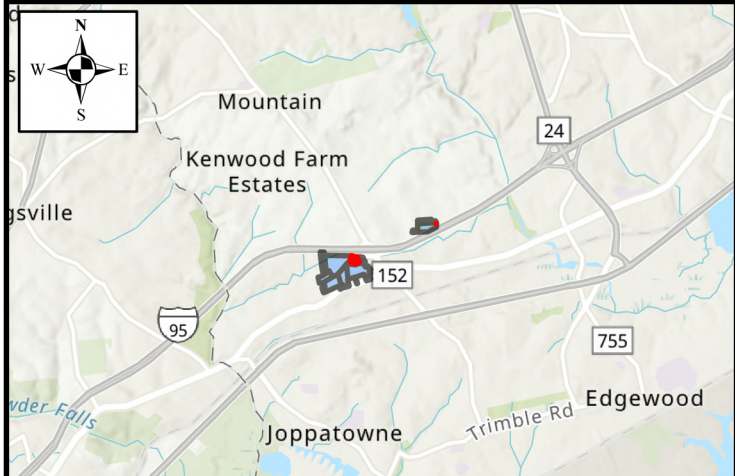


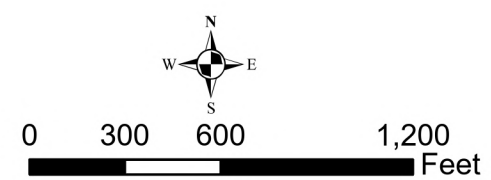
## I-95 ETL NORTHBOUND EXTENSION PHASE II ROADWAY ADJACENT PROPERTIES MAP
